RESOLUTION AUTHORIZING BINDING VARIOUS LIABILITY, PROPERTY, CRIME AND WORKERS' COMPENSATION COVERAGES FOR 2020

WHEREAS, the Town of Greenburgh desires to bind insurance coverages for various liability, property and workers' compensation for 2020 and enter into an agreement for general liability and automobile liability claims handling services; and

WHEREAS, the Town's Comptroller has worked with the insurance brokers and claims handling administrator in providing renewal applications, other information requested by the insurance underwriters, and answering their questions; and

WHEREAS, the Town Board has considered other brokers over the course of several months and determined that continuing with the current brokers is in the best interest of the Town; and

WHEREAS, after many months of time, effort, and discussion with the insurance brokers and underwriters, renewal quotations have been obtained; and

WHEREAS, such coverages, brokers, policy premiums, and other pertinent information have been provided to the Town Board for the 2020 property, liability, workers' compensation, and claims handling services renewals;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Greenburgh hereby will bind coverages and claims handling services before the end of the current policy period, December 31, 2019 to December 31, 2020 in amounts not to exceed in the aggregate \$742,685 for property and liability coverage with USI Insurance Services, and \$1,811,053 for workers' compensation coverage with NYS Municipal Workers' Comp Alliance; and

BE IT FURTHER RESOLVED, the Town Supervisor or the Supervisor's designees are hereby authorized to enter into agreements for the insurance coverages and claims handling services consistent with the above for the policy period December 31, 2019 to December 31, 2020.

RESOLUTION APPOINTING WENDELL BARBOUR AND JOANNY JAMES AS ENTRY-LEVEL POLICE OFFICERS

WHEREAS, the Town Board has authorized the sworn strength of the Greenburgh Police Department to be 115; and

WHEREAS, Wendell Barbour and Joanny James are currently certified police officers and can commence required field training immediately; and
