## MINUTES Town of Greenburgh Board of Ethics 6:30 p.m. Thursday, June 22, 2023 Town Hall, Lee F. Jackson Conference Room

- 1. The meeting was convened at 6:30 p.m. A quorum of the Board of Ethics (BoE) was present.
- 2. AGENDA: The Agenda, as per motion of the Chair, was unanimously adopted.

- AMENDMENT TO BOARD OF ETHICS RULES & REGULATIONS (Rule 4 (j). Preliminarily, Deputy Town Attorney Magana relayed Town Attorney Danko's request that the BoE withhold any vote on the proposed amendment to the rules to allow the public opportunity to voice their comments.

The Chair read the proposed amendment and invited the members of the Board and the public to comment. There was no comment at this time; however, voting on the proposed amendment was held in obeyance until the next meeting.
